The Citizens’ Utility Board of Oregon (CUB) files this Notice of Intent to Request Issue Fund Grants in UM 1673, pursuant to OAR 860-001-0120 the Second Amended and Restated Intervenor Funding Agreement (“IFA”),<sup>1</sup> and the Idaho Power-CUB Intervenor Funding Agreement (“Idaho Power IFA”).<sup>2</sup>

1. The Public Utility Commission of Oregon has opened a docket for its Report to the Legislature on Effectiveness of Incentive Programs for Solar Photovoltaic Energy. The Commission will examine this filing in Docket No. UM 1673.
2. UM 1673 is an Eligible Proceeding under both the IFA and the Idaho Power IFA. IFA, Article 6.1; Idaho Power IFA, Article 6.1.

<sup>1</sup>The Second Amended and Restated Intervenor Funding Agreement was approved by the Commission in Order No. 12-452 (Nov. 20, 2012). Though the Agreement’s effective date is January 1, 2013, the vast majority of the time and resources necessary for this docket will be incurred in 2013.

<sup>2</sup>The Idaho Power-CUB Intervenor Funding Agreement was approved by the Commission in Order No. 10-396 (Oct. 13, 2010).

3. UM 1673 will directly affect PGE, PacifiCorp and Idaho Power, which are Participating Public Utility under their respective intervenor funding agreements. IFA, Article 1(k); Idaho Power IFA, Article 1(h).
4. As required by each intervenor funding agreement, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list from UM 1673.
5. CUB identifies the 2013 PGE Issue Fund, the 2013 PacifiCorp Issue Fund, and the 2013 Idaho Power Issue Fund as the accounts from which CUB intends to request the Issue Fund Grants.
6. CUB has been pre-certified under both intervenor funding agreements and OAR 860-001-0120(3)(a) as eligible to receive an Issue Fund Grant. IFA, Article 5.2; Idaho Power IFA, Article 5.1.
7. CUB will file a proposed budget with respect to each requested issue fund grant, as provided in Article 6.3 of the IFA and Article 6.3 of the Idaho Power IFA.
