Staff has reviewed this matter further and recognizes PGE's need to have an expedited schedule in this matter. Accordingly, Staff has determined that it will be able to proceed on a "public meeting" schedule, as requested by PGE, rather than on a "contested case" track.

Staff conferred today with PGE about the possibility of having this matter heard at the Commission's regularlyscheduled June 7 public meeting, rather than at an earlier special public meeting as PGE first requested.
