Pursuant to Section 7.3 of the Fourth Amended and Restated Intervenor Funding Agreement (“IFA”) approved by the Oregon Public Utility Commission (“Commission”) in Order No. 18-017 (January 17, 2018), the Alliance of Western Energy Consumers (“AWEC”) hereby requests that AWEC’s remaining Issue Fund Grant in Docket No. UM 1824 in the amount of \$10,600 be reallocated for use in Docket No. UM 1968.

On January 18, 2018, AWEC (then the Industrial Customers of Northwest Utilities) filed a Request for Issue Fund Grant and Proposed Budget in Docket No. UM 1824, showing eligible expenses in the amount of \$37,500 and requesting an Issue Fund Grant in the amount of \$30,000. On January 30, 2018, the Commission issued Order No. 18-030, approving an Issue Fund Grant for AWEC in the amount of \$30,000. On September 19, 2018, AWEC requested that the Commission authorize partial payment of the approved Issue Fund Grant in Docket No. UM 1824 in the amount of \$3,999.60, while requesting that \$15,400 of AWEC’s approved grant be reallocated for use in Docket No. UM 1845. The Commission approved AWEC’s requests on October 3, 2018, via Order 18-367.

Pursuant to Article 6.7 of the IFA, AWEC is now requesting that the remaining \$10,600 of its approved UM 1824 Issue Fund Grant be reallocated to Docket No. UM 1968 for use in that proceeding. AWEC is concurrently filing its Request for Issue Fund Grant and Proposed Budget in Docket No. UM 1968 as well as a motion to designate UM 1968 as an eligible proceeding for Issue Funds. AWEC's request for reallocation in this docket is contingent upon the Commission's approval of AWEC's filings in UM 1968.

Upon approval of this Request for Reallocation of Issue Fund Grant, the balance of the UM 1824 Issue Fund Grant will be \$0, and the balance of AWEC's Proposed Budget in Docket No. UM 1968 will be \$17,740.^{1/}
