PARTIES STATUS REPORT

On January 24, 2018, a prehearing conference was held in the above-captioned complaint proceedings. On January 26, 2018, the Administrative Law Judge (ALJ) issued a prehearing conference report and ruling that temporarily suspended the proceedings to enable the Parties to engage in discussions leading to a possible settlement of the complaints. The ruling required the parties to advise the Commission as to the status of their discussions on or before February 23, 2018. On February 23, 2018, the Parties filed a status report and indicated that they were still exploring settlement. On February 26, 2018, the ALJ issued a ruling continuing to suspend the proceedings and directing the parties to file a status report on or before April 27, 2018.

On February 26, 2018, Complainant SSD Clackamas 1 LLC and Complainant SSD Clackamas 7 LLC each filed a motion for partial summary judgment. The parties have filed a


series of joint motions to extend the deadline for PGE to respond and the ALJ has granted those motions to allow the parties more time to finalize settlement.

The parties are actively engaged in settlement discussions and anticipate finalizing settlement soon. The parties recommend that the ALJ continue the existing suspension. The parties continue to reserve their rights to file motions, including motions for summary judgment, at any time.
