PARTIES STATUS REPORT


On January 24, 2018, a prehearing conference was held in the above-captioned complaint proceedings. On January 26, 2018, the Administrative Law Judge (ALJ) issued a prehearing conference report and ruling that temporarily suspended the proceedings pending the filing of motions for summary judgment. The ruling required the parties to advise the Commission as to the status of their discussions or of the cases generally on or before February 23, 2018.

The parties state that there has been no change in the status of the cases and recommend the ALJ continue the existing suspension. The parties continue to reserve their rights to file motions, including motions for summary judgment, at any time.


