

PARTIES' STATUS REPORT

On January 24, 2018, a prehearing conference was held in the above-captioned complaint proceedings. On January 26, 2018, the Administrative Law Judge (ALJ) issued a prehearing conference report and ruling that temporarily suspended the proceedings pending the filing of motions for summary judgment. The ruling required the parties to advise the Commission as to the status of their discussions or of the cases generally on or before February 23, 2018.

On February 23, 2018, the Parties filed a report that there had been no change in status. On February 26, 2018, the ALJ issued a ruling continuing the suspension of the proceedings and requiring the Parties to file a status report on or before April 27, 2018.

On April 27, 2018, the Parties filed a report that there had been no change in status. On April 30, 2018, the ALJ issued a ruling continuing the suspension of the proceedings and requiring the Parties to file a status report on or before June 29, 2018. On June 27, 2018, the Parties filed a report that there had been no change in status.


