**ERRATA TO PORTLAND  
GENERAL ELECTRIC  
COMPANY’S MOTION FOR  
SUMMARY JUDGMENT**

Portland General Electric Company (“PGE”) respectfully submits the attached Exhibit A document as an errata filing to replace the Exhibit A attached to PGE’s January 24, 2018, motion for summary judgment filed in the above-captioned proceedings (“Motion for Summary Judgment”).

PGE’s Motion for Summary Judgment included Exhibit A, which is a table intended to summarize the dates provided in the “Summary of Relevant Facts” section of the Motion for Summary Judgment.<sup>1</sup> The “Summary of Relevant Facts” includes six tables (Table A through Table F) and Exhibit A combines key dates from these six tables for ease of reference. The last

column of Exhibit A—entitled “Assessment: Earliest Date Executable Due Based on Initial Change Request”—is intended to summarize the information contained at the top of page 13 of the Motion for Summary Judgment. Specifically, the relevant portion of page 13 states:

Assuming *arguendo* that each Complainant accepted all of the terms and conditions in the revised draft contracts provided by PGE on June 14, 2017, then the *earliest* that each Complainant would have been entitled to an executable PPA would have been 15 business days later on July 6, 2017. As a result, even if the Commission had set the effective date of the May 1 avoided cost rate update at June 28, 2017, as requested by Renewable Energy Coalition and other QF representatives and stakeholders, it would not have made any substantive difference. Having requested changes to their draft PPAs on May 23, 2017, none of the Complainants had a right to an executable PPA before July 6, 2017, at the earliest.<sup>2</sup>

Consistent with this analysis from the body of the Motion for Summary Judgment, the last column of the table enclosed as Exhibit A should have stated that the earliest date an executable contract could be due based on the date of Complainants’ initial requests for changes to their draft PPAs was **July 6, 2017**; but instead the last column of the table erroneously summarized the date as June 14, 2017. PGE has enclosed with this filing a corrected version of the table provided as Exhibit A to the Motion for Summary Judgment. The only change to Exhibit A is to correct the date in the last column from the erroneous June 14, 2017 date to the correct July 6, 2017 date.

PGE respectfully requests that the Commission replace the version of Exhibit A submitted with the January 24, 2018 Motion for Summary Judgment with the corrected version




