In response to your request for comments on the schedule in UM 1934, due today, the parties to the docket have been working diligently to attempt to arrive at a consensus schedule and I believe we have one. Given this agreement, I am hopeful that this email will suffice as a response to the notice you issued yesterday. Please let me know if you would like a formal filing in the docket. The following parties support the schedule below: PGE, Staff, CUB, AWEC, NIPPC, and Renewable Northwest. In addition, while the Community Renewable Energy Association (CREA) has not yet weighed in on this schedule, it previously expressed support for a similar schedule, so I do not expect that they will object. I have not heard from any other potentially interested party with regard to this schedule. The schedule is as follows:

Stakeholder comments: October 25th
PGE reply comments: November 5th
Staff memo: November 21st
PGE/Stakeholder comments on Staff memo: November 29th
Commission decision at Public Meeting: December 4th

In addition to this schedule, the parties have agreed to a 7 calendar day turnaround for information requests received until October 18th and for information requests received from November 5th to November 9th. For all other dates, the discovery response timeline will be a 14 calendar day turnaround.
