RE: UM 1934 – Portland General Electric Company’s Update to the Schedule for the 2018 Request for Proposals for Renewable Resources

Portland General Electric Company (PGE) provides to the Public Utility Commission of Oregon (Commission) an updated schedule for its 2018 Request for Proposals for Renewable Resources (2018 RFP).

PGE provides this updated schedule to include dates for (1) Staff and Interested Parties to file comments on PGE’s Request for Commission Acknowledgement of the Final Short List and on the Independent Evaluator’s Final Closing Report, (2) PGE’s Reply Comments to Staff and Interested Parties Comments, (3) Staff’s Memo, (4) PGE and Interested Parties Comments on Staff Memo, and (5) Commission’s Public Meeting for Commission decision¹.

The table below provides the updated schedule as described herein.

PGE has discussed this updated schedule with Commission Staff and Staff finds it acceptable. NIPPC, CUB, AWEC, CREA and RNW (NIPPC) proposed modifications to the schedule which would (1) elongate the time for Staff and Interested Parties comments, (2) shorten the time for PGE's reply comments, (3) create an additional round of Stakeholder only comments, and (4) create a final opportunity for PGE and stakeholder to provide final comments following Staff's report. PGE has accepted NIPPC's proposal for final comments on the Staff report as reflected in the schedule above. PGE was unable to accept NIPPC's other modifications. PGE consulted with NIPPC (as lead for the other entities on this issue) in an attempt to resolve our differences. The parties were unable to come to complete resolution.
