STAFF STATUS REPORT

11           In a ruling issued October 17, 2012, the administrative law judge (ALJ) granted  
12          Commission Staff's request to suspend the procedural in these dockets because the parties had  
13          reached a settlement in principle resolving all issues presented in the docket. She directed that  
14          Staff file the stipulation by November 7, 2012, or file a status report on that day explaining when  
15          the stipulation will be filed.

16           Parties took until October 26, 2012, to finalize the details of their agreement. Since that  
17          time, Staff counsel has been engaged doing other work, but will begin drafting the stipulation for  
18          this docket this week. By no later than early next week, Staff will circulate to the settling parties  
19          a draft of the stipulation and supporting testimony. To ensure that Staff has sufficient time in  
20          which to draft the stipulation and supporting testimony and that the settling parties have



1 sufficient time to review the stipulation, Staff asks that the ALJ establish Tuesday, November 20,  
2 2012, as the deadline to file the Stipulation and supporting testimony. However, staff will file


