Re: PUBLIC UTILITY COMMISSION OF OREGON Investigation of Fuel Switching and Cross Fuel Energy Efficiency Issues

On March 21, 2012, ALJ Hardie ruled that the parties in docket UM 1565 should file a status report and issues list by March 28, 2012. The Citizens' Utility Board of Oregon ("CUB") was unable to reach an agreement with the other parties to this proceeding regarding a single issues list. Therefore, pursuant to ALJ Hardie's ruling, CUB submits the following issues list for UM 1565:

- **Issue 1**: Is fuel switching occurring with respect to space conditioning?
- **Issue 2:** Is fuel switching uneconomic to ratepayers?
- Issue 3: Staff's third issue has suddenly become broad in its scope but narrow in looking solely at the ETO. If this docket is going to look at the broad subject of heat pumps and high-efficiency furnaces, it should not be limited to programs market by the ETO. Rather, the docket should also be looking at programs marketed by the utilities themselves, such as programs that Idaho Power markets to the customers of Cascade Natural Gas. CUB does not understand why Staff appears to be carving out programs marketed by utilities. As an example, CUB's Executive Director, Bob Jenks, who has a new gas furnace, has received three letters (attached) from PGE encouraging him to take advantage of high-efficiency heat pumps. Though the letters cite ETO incentives, possible tax credits, and an additional \$200 incentive available through PGE-approved contractors, the letters are on PGE's letterhead. CUB questions whether these letters or similar letters from other utilities are an appropriate use of SB 838 funds. It is with that in mind that CUB proposes its third issue: What is the impact of incentive programs, such as the incentives for high efficiency heat pumps, and the marketing of such incentive programs, on fuel switching?
- **Issue 4:** Given the above, should ratepayer-funded messaging, policies, or practices from utilities or the Energy Trust be modified?

CUB otherwise supports the status report filed by Commission Staff.
