Portland General Electric (PGE) hereby requests an extension of the deadline for public comment in docket AR 567 for an additional 30 days until November 20, 2012. Because the due date for public comment is October 18, 2012, PGE requests expedited consideration of this Motion under OAR 860-001-0420(7).

The parties in this docket would benefit from additional time for public comment in order to consider issues identified at the hearing in this docket. The parties intend to discuss ways in which to craft a billing error reporting rule that addresses those issues and aligns the interests of stakeholders in this process. PGE has contacted the other parties in this docket regarding this Motion. Staff of the Public Utility Commission (Staff), the Citizens' Utility Board (CUB), and PacifiCorp have stated that they do not oppose this Motion. PGE has received no objection from any of the other remaining utilities in this docket. PGE does not expect any party to file a response to this Motion, however, to comply with OAR 860-001-0420(7)(c), PGE requests that the time for responses be shortened to enable issuance of an order before October 18, 2012.

For the reasons stated above, PGE respectfully requests that deadline for public comment be extended until November 20, 2012.
