Pursuant to OAR §§ 860-001-0000(2) and 860-001-0400(5), the Renewable Energy Coalition (the "Coalition") moves for leave to file a reply to PacifiCorp's Response to the Coalition's Petition for Declaratory Ruling. Replies have been filed in previous declaratory ruling dockets, including DR 46 (Response of Troutdale Energy Center, LLC) and DR 43 (Reply of NW Natural Gas Co.). Moreover, good cause exists to allow the Coalition to file a reply. As more thoroughly discussed in its Reply, which is attached to this Motion, PacifiCorp's response may create the impression that only one qualifying facility ("QF") would be impacted by the Coalition's Petition; however, this Petition will in fact have much broader potential impact. Additionally, PacifiCorp's argument that the Commission can address the issue raised by the Coalition in its UM 1610 investigation is incorrect, as is the Company's assertion that a ruling on the Petition will be ineffective to bind QFs and the Company. For these reasons, and as discussed more thoroughly in its Reply, the Coalition respectfully requests that the Commission grant leave to file the attached Reply to PacifiCorp's Response.
