The Parties have conferred regarding this Motion and agree that it is appropriate.

The Prehearing Conference Order the Commission entered on October 17, 2012, set a schedule for both parties to file their direct testimony by December 14, 2012, responsive testimony by January 15, 2013, and set the hearing on January 29, 2013. The Parties have not completed their respective case preparation, analysis and discovery, and for that reason ask that the current schedule, including testimony filings and the hearing date, be vacated.
