14	it would be helpful to the Commission to have input from other parties regarding the IRP					
15	Update. To allow parties sufficient opportunity to prepare any comments, staff asks that the					
16	Idaho Power presentation be moved from April 1, 2013 to the regular public meeting scheduled					
17	on April 23, 2013.					
18	Staff consulted with Idaho Power Company, the Renewable Northwest Project, and the

21	March 26, 2013, and asked any party to respond by noon on Wednesday, March 27, 2013, if they


