The Klamath Water Users Association ("KWUA") hereby moves for a modification to the briefing schedule in this proceeding. Currently, the Opening Brief in this proceeding is due to be filed by March 3, 2006. At this time, only the first half of the first day of the transcript of the hearing held February 16th and 17th has been completed. Due to the delay in receiving the transcript, it has become problematic for the parties to meet the current deadline for filing the Opening Brief.

KWUA hereby requests that the deadline for filing the Opening Brief be changed to the close of business on Monday, March 6, 2006. In light of the very limited availability of the Commissioners for an Oral Argument in the month of March, 2006, KWUA is not seeking a change in the date for oral argument, which is set for March 15, 2006.
