**NOTICE OF WITHDRAWAL OF PETITION TO INTERVENE OF THE PACIFIC  
COAST FEDERATION OF FISHERMEN'S ASSOCIATIONS (PCFFA) IN  
DOCKET NO. UE-170  
AND INTENT TO INTERVENE IN DOCKET NO. UE-171**

On 19 February 2005, the Pacific Coast Federation of Fishermen's Associations, Inc. ("PCFFA") filed a Petition to Intervene in this docket to present evidence specifically on the discriminatory impacts of the current Upper Klamath Basin agricultural power rate tariff. However, on 24 February 2005, the Administrative Law Judge opened a separate Docket No. UE-171 for the specific purpose of addressing all those particular issues in a parallel process. On 2 March 2005, the Administrative Law Judge established a deadline of 14 March 2005 within which to petition to intervene in Docket No. UE-171 for that purpose.

The opening of Docket No. UE-171 makes the Petition of PCFFA to intervene in Docket No. UE-170 unnecessary. In telephone consultation with Administrative Law Judge Traci A. G. Kirkpatrick on 2 March 2005, she suggested to me that, in the interests

of simplicity and convenience, PCFFA simply withdraw its petition in this docket and resubmit a Petition to Intervene in related Docket No. UE-171.

This filing is therefore to notify you that PCFFA hereby withdraws its Petition to Intervene in this Docket UE-170, and of its intent to file a separate Petition to Intervene in new Docket No. UE-171.
