9	INTRODUCTION		
10	On May 27, 2005, ALJ Logan issued a ruling that established July 13, 2005 as the due		
11	date for prehearing briefs. On June 14, 2005, ALJ Logan provided that the prehearing brief		
12	format should be similar to a written opening statement and that the parties should address each		
13	issue separately with the parties' positions of the issues.		
14	In addition to the prehearing brief date, the current schedule provides that PacifiCorp wi		
15	file its sursurrebuttal testimony on July 11, 2005, and the evidentiary hearing is scheduled for		
16	July 20-23, 2005.		
17	ANA	LYSIS	
18	The Public Utility Commission of Oregon Staff ("Staff") respectfully requests that the		
19	prehearing briefing date of July 13, 2005 be changed to July 18, 2005, by noon. Staff has		
20	contacted Staff, CUB and ICNU about this extension and understands these parties do not		
21	oppose this request.		
22	Although the prehearing brief date has been established since May 27, 2005, Staff, in		
23	preparation for the prehearing brief date, has become more aware of the very short timeframe		
24	between the date that PacifiCorp files its sursurrebuttal testimony (July 11 <sup>th</sup> ) and the date		
25	prehearing briefs are due (July 13 <sup>th</sup> ). As a practical matter, it would be very difficult to consider		
26	PacifiCorp's sursurrebuttal testimony in the parties' prehearing briefs.		

1	Staff understands that the intent of the prehearing briefs is to outline the parties own		
2	positions. However, it is possible that PacifiCorp's sursurrebutal testimony could impact the		
3	parties' positions and, thus, their prehearing briefs. As a result, Staff requests that the prehearing		
4	briefs be filed on July 18, 2005, by noon, which will allow the parties additional time to consider		
5	PacifiCorp's sursurrebuttal testimony in preparing their prehearing briefs.		
6	For the foregoing reasons, Staff respectfully requests the due date for the prehearing		
7	briefs be amended from July 13, 2005, to July 18, 2005, by noon.
