**REQUEST FOR PREHEARING  
CONFERENCE AND SUSPENSION  
EXTENSION AGREEMENT**

On June 24, 2009, Portland General Electric ("PGE") filed a Motion for Postponement of Prehearing Conference. In that motion, PGE requested that the scheduled prehearing conference be postponed, and stated that by July 7, 2009, PGE would file either an agreed upon schedule or a request that the date for the prehearing conference be reset. No party in this docket objected to PGE's request. On June 24, 2009, the Administrative Law Judge granted PGE's motion.

Parties have not been able to reach consensus on a schedule. Accordingly, PGE requests that the Commission set a prehearing conference in this matter for the purpose of establishing a schedule for the remainder of this docket. PGE requests that the prehearing conference be set during the week of July 27, 2009 through July 31, 2009, if possible.

The ALJ's June 24, 2009, Ruling in this docket also noted that the suspension date for PGE's filing in this docket ends July 15, 2009, and that prior to that date PGE must file written authorization with the Commission allowing further extension. PGE hereby agrees to a four-

month extension of the suspension date for its filing in this docket, to November 15, 2009.
