REQUEST REGARDING PROCEDURAL
SCHEDULE

On April 14, 2009, Portland General Electric (“PGE”) filed a Motion for Amendment to Procedural Schedule in this docket, which included a request for expedited consideration. That motion stated that PGE had experienced a delay in the construction of the Selective Water Withdrawal Project (“SWW”), and requested that the procedural schedule be suspended. The motion further stated that PGE would work with the other parties and file, by May 15, 2009, a request with the Administrative Law Judge regarding scheduling the remainder of the docket. The motion also represented that the other parties to this docket supported the motion.


On April 15, 2009, the ALJ issued a ruling granting PGE’s motion.

Analysis of the cause of the construction delay at the SWW, and development of the plan for completion, are ongoing and will continue for some time. PGE requests that a prehearing conference be set in this docket for June 25, 2009, at which time a schedule for the remainder of the docket can be established. By that time PGE anticipates that it will have in place a new schedule for completion of the SWW project. Staff of the Public Utility Commission, the Citizens’ Utility Board, and the Industrial Customers of Northwest Utilities, the other parties in

this docket, support this request and are available for a prehearing conference on June 25.
