Pursuant to OAR 860-013-0031, Portland General Electric ("PGE") requests that the prehearing conference set in this docket for June 25, 2009, be postponed. Pursuant to a previous request by PGE, supported by the other parties in this docket, the Commission suspended the schedule in this docket and set a prehearing for June 25, 2009. PGE desires a little additional time to discuss this matter with the parties, and assess the status of the Selective Water Withdrawal project and its construction schedule prior to a prehearing conference. PGE has contacted the other parties in this docket, Staff of the Public Utility Commission ("Staff"), the Citizens' Utility Board ("CUB"), and the Industrial Customers of Northwest Utilities ("ICNU"), and no party objects to this request.

The parties intend to meet later this week to discuss this docket. If acceptable to the Administrative Law Judge, PGE will, by July 7, 2009, file with the Commission either an agreed upon schedule for the remainder of this docket, or a request that the date for the prehearing conference be reset.


**EXPEDITED CONSIDERATION REQUEST**


