10	2012. <sup>1</sup> Counsel for Idaho Power Company (Idaho Power) and the Oregon Industrial Customers			
11	of Idaho Power (OICIP) have been contacted regarding this motion and neither opposes it.			
12	The request for extension stems from discussions between CUB and IPCo regarding			
13	modifications to the intervals between testimony due dates. CUB desired additional time to			
14	prepare surrebuttal testimony and IPCo has agreed to the request.

16	For the foregoing reasons, Staff and CUB ask the ALJ to extend the due date for staff and			
17	intervenor surrebuttal testimony from January 19, 2012 to January 25, 2012.
