16 Power Company in this matter. (See Idaho Power/100-104 and 200-204).

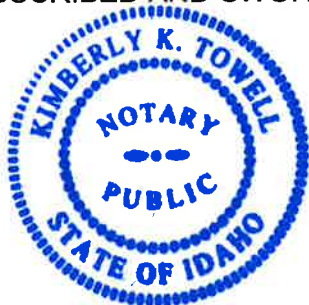
