MOTION TO SUSPEND PROCEDURAL SCHEDULE

EXPEDITED CONSIDERATION REQUESTED

For the reasons set out below, Portland General Electric Company ("PGE") hereby requests that the remaining procedural schedule in this docket be suspended.

On July 22, 2014, PGE, Staff of the Public Utility Commission ("Staff"), the Citizens' Utility Board ("CUB") and the Industrial Customers of Northwest Utilities ("ICNU") (together the "Stipulating Parties") filed a Stipulation resolving all but three issues in this docket. No other parties filed testimony in this docket. The Stipulating Parties held further settlement discussions, the most recent on July 28, 2014. As a result of those discussions, the Stipulating Parties have reached an agreement resolving all remaining issues in this docket. The Stipulating Parties are in the process of drafting a Stipulation and supporting joint testimony.

As a result of this settlement, PGE respectfully requests that Administrative Law Judge suspend the remaining procedural schedule in this docket. The other Stipulating Parties support this motion.

CONCLUSION AND EXPEDITED CONSIDERATION REQUEST

For the reasons discussed above, PGE requests that the Administrative Law Judge issue an order suspending the remaining procedural schedule in this docket. Pursuant to the schedule
