**MOTION TO SUSPEND PROCEDURAL

**EXPEDITED CONSIDERATION  
REQUESTED**

For the reasons set out below, Portland General Electric Company ("PGE") hereby requests that the remaining procedural schedule in this docket be suspended.

On March 5, 2015, a settlement conference was held in this docket. Staff of the Oregon Public Utility Commission, the Citizens' Utility Board of Oregon, and the Industrial Customers of Northwest Utilities participated in the settlement discussions. There are no other parties to this docket. As a result of those discussions the parties have reached agreement settling all issues in this docket.

All parties are in the process of completing a stipulation and supporting joint testimony, and anticipate filing the stipulation and testimony later this week or early week.

As a result of this settlement, PGE respectfully requests that Administrative Law Judge suspend the remaining procedural schedule in this docket. The other parties to this docket support this motion.

**CONCLUSION AND EXPEDITED CONSIDERATION REQUEST**

For the reasons discussed above, PGE requests that the Administrative Law Judge issue an order suspending the remaining procedural schedule in this docket. Pursuant to the schedule
