**MOTION TO SUSPEND PROCEDURAL  
SCHEDULE**

**EXPEDITED CONSIDERATION  
REQUESTED**

9 Pursuant to OAR 860-001-0420, Idaho Power Company (“Idaho Power” or “Company”)  
10 requests that the procedural schedule in this case be suspended. Settlement discussions in  
11 this case took place on April 28, 2016. As a result of these settlement discussions, all of the  
12 parties (Idaho Power, Staff of the Public Utility Commission of Oregon, and the Citizens’ Utility  
13 Board of Oregon (“CUB”) (collectively, the “Parties”) have reached a settlement in principle that  
14 will resolve all of the issues related to Idaho Power’s 2015 Annual Power Supply Expense True-  
15 Up.

16 Idaho Power requests expedited consideration of this motion because the procedural  
17 schedule calls for Staff and CUB to file testimony on May 12, 2016. As required by OAR 860-  
18 001-0420(2) and (6)(a), Idaho Power has conferred with the Parties and all support this motion.  
19 The Parties intend to file the Stipulation and supporting documentation by May 13, 2016. If the  
20 Stipulation and supporting documentation is not filed by May 13, 2016, the Parties will file a  
21 status update.
