For the reasons explained herein, Noble Americas Energy Solutions LLC (or "Noble Solutions") moves the Public Utility Commission of Oregon ("OPUC") to substitute Calpine Energy Solutions, LLC (or "Calpine Solutions") as a party in this matter and to make a corresponding change to the service list.

On December 1, 2016, the owners of Noble Americas Energy Solutions LLC sold their ownership interests in Noble Americas Energy Solutions LLC to Calpine Corporation. The transaction resulted in a change of the name Noble Americas Energy Solutions LLC to Calpine Energy Solutions, LLC.

On December 14, 2016, the OPUC approved the name change and certified Calpine Energy Solutions, LLC as an Electricity Service Supplier under Oregon law. PUC Order No. 16-479 (Dec. 14, 2016), available at http://apps.puc.state.or.us/orders/2016ords/16-479.pdf. The name of Noble Americas Energy Solutions LLC has therefore changed, but the underlying entity's other business operations and functions, as well as its rights and interests supporting its intervention and participation in this proceeding, remain unchanged.

The applicable procedural rules provide: "In case of any transfer of interest, the action may be continued by or against the original party, unless the court upon motion directs the

original party." ORCP 34E; see also OAR 860-001-0000 (adopting Oregon Rules of Civil

Procedure unless inconsistent with the OPUC's administrative rules).

In order to properly reflect the transfer of interest and the new name, Noble Americas

Energy Solutions LLC moves the OPUC to substitute Calpine Energy Solutions, LLC as a party

in this matter.
