14	a cross-examination statement stating that Noble does not intend to participate in any hearing
15	regarding Docket No. UE 308. However, Staff contacted counsel for Noble regarding this
16	motion and Noble does not object.
17	Staff seeks this extension because ICNU and Staff have issued data requests to PGE
18	regarding PGE's September 2, 2016 testimony. PGE intends to respond to the data requests by
19	September 12, 2016. Whether Staff and ICNU would like to conduct cross-examination turns at
20	least in part on the discovery responses. Accordingly, the parties would like until September 13,
21	2016, to submit cross-examination statements and exhibits.
22	Because the cross-examination statements are due today, September 9, 2016, Staff requests
23	expedited consideration of this motion under OAR 860-001-0420(6). Staff certifies that all parties
