9	Pursuant to OAR 860-001-0420, Idaho Power Company ("Idaho Power" or "Company")		
10	requests that the procedural schedule in this case be suspended. Settlement discussions in		
11	this case took place on May 1, 2017. As a result of these settlement discussions, all of the		
12	parties (Idaho Power, Staff of the Public Utility Commission of Oregon, and the Oregon Citizens		
13	Utility Board ("CUB") (collectively, the "Parties")) have reached a settlement in principle that will		
14	resolve all of the issues related to Idaho Power's 2016 Annual Power Supply Expense True-Up.		
15	Idaho Power requests expedited consideration of this motion because the procedura		
16	schedule calls for Staff and CUB to file testimony on May 15, 2017. As required by OAR 860-		
17	001-0420(2) and (6)(a), Idaho Power has conferred with the Parties and all support this motion		
18	The Parties intend to file the Stipulation and supporting documentation by May 10, 2017. If the		
19	Stipulation and supporting documentation is not filed by May 10, 2017, the Parties will file a		
20	status update.		
21	For the foregoing reasons, Idaho Power requests the suspension of the procedura		
22	schedule.
