MOTION TO ADMIT TESTIMONY AND EXHIBITS OF CALPINE ENERGY SOLUTIONS, LLC

Calpine Energy Solutions LLC ("Calpine Solutions") hereby moves to admit its testimony and exhibits into the evidentiary record in this proceeding.

Specifically, Calpine Solutions moves for the admission of the opening and rebuttal testimony of Kevin C. Higgins in this proceeding, which are Calpine Solutions/100 through Calpine Solutions/105 and Calpine Solutions/200 through Calpine Solutions/202, respectively.
