PACIFICORP'S STIPULATED MOTION TO MODIFY PROCEDURAL SCHEDULE

(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, Pacific PacificOrp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order amending the procedural schedule in this docket. PacifiCorp's reply testimony is currently due on Monday, July 9, 2018, and therefore PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6). Staff of the Public Utility Commission of Oregon (Staff), the Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy Consumers (AWEC), and Calpine Energy Solutions LLC (Calpine Solutions) (collectively with PacifiCorp, the Stipulating Parties) support this motion. No party to this case opposes the motion.

The Stipulating Parties have reached a partial settlement in principle that resolves all but one disputed issue in the 2019 Transition Adjustment Mechanism (TAM). The Stipulating Parties request changes to the current procedural schedule to allow them to finalize and execute a partial stipulation and to address litigation of the remaining disputed issue.

The Stipulating Parties request that the Commission approve the following procedural schedule:
