Dear Commission Staff:

United States Cellular Corporation ("USCC") files this letter requesting the Commission issue an errata to Order No. 04-356 dated June 24, 2004 ("Order"). The errata is necessary to correct the list of wire centers in the Order for which USCC has ETC designation. A proposed errata with the correct list is attached to this letter as Exhibit A ("Revised Wire Center List"). Commission staff reviewed this letter prior to filing and supports USCC's request.

USCC filed an application on May 9, 2003 for ETC designation in certain wire centers. The Order granting ETC designation included the wire centers listed in Appendix B (attached as Exhibit B).

USCC and Commission staff have reviewed Appendix B and determined that corrections are necessary. The corrections fall into two general categories: (1) clarifications to the exchanges and wire centers (including adding CLLI codes and correcting wire center names); and (2) adding wire centers that were included in USCC's application and map but omitted from the Order. Explanations for the requested revisions are attached as Exhibit C.

The specific revisions are as follows:

• Correcting "Standfield" to Stanfield;

- Correcting "Lostin" to Lostine;
- Deleting Ash Valley (it is not a wire center but an exchange included in the Elkton wire center); and
- Adding the following wire centers that were included in the application but omitted from the Order: Oregon portion of Walla Walla, Empire, and Condon.

USCC requests the Commission exercise its authority under ORS 756.561 to correct the Order by issuing an errata to replace Appendix B with the Revised Wire Center List. These changes are not substantive and will conform the wire center list in the Order with the actual wire centers for which USCC sought ETC designation in docket UM 1084. USCC reserves its right to later apply for ETC designation in any wire center in Oregon.
