


AFFIDAVIT OF BOB JENKS

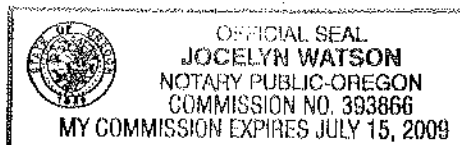
