

5. As an in-house attorney, I am exempt from the Oregon State Bar Professional Liability Fund plan requirements.



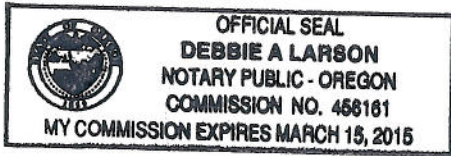
