11 Natural Gas Division of the Public Utility Commission of Oregon.

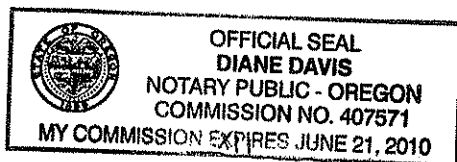
12 2. I am the same Ed Durrenberger that previously filed testimony and accompanying
