MOTION TO ADMIT CUB’S
REVISED NOTICE OF INTENT TO
REQUEST AN ISSUE FUND GRANT

The Citizens’ Utility Board of Oregon (“CUB”) respectfully requests that the Administrative Law Judge admit CUB’s Revised Notice of Intent to Request an Issue Fund Grant in docket UM 1565. The Public Utility Commission of Oregon opened an Investigation of Fuel Switching and Cross Fuel Energy Efficiency Issues on December 6, 2011. CUB timely filed both its Notice of Intervention and its Notice of Intent to Request an Issue Fund Grant on December 27, 2011. However, in its original filing of the Notice of Intent to Request an Issue Fund Grant, CUB mistakenly identified the PacifiCorp, PGE and Idaho Power Issues Funds as the issue funds from which CUB would be seeking grants. CUB erred in its Notice of Intent to Request an Issue Fund Grant in that CUB meant to identify the Northwest Natural, Avista and Cascade Natural Gas issues funds in its Notice. CUB became aware of its error today, January 25, 2012, the same date that Intervenor budgets are due in this docket. CUB does not believe that granting this Motion would negatively impact other parties in this docket.

Therefore, CUB respectfully requests that its Revised Notice of Intent to Request an Issue Fund Grant be admitted.
