Northwest Natural Gas Company, dba NW Natural, encloses for filing with the Public Utility Commission of Oregon (Commission) its Motion to Amend Order No. 20-501 Extending the Temporary Waiver of OAR 860-021-0130(2) related to the right of a customer to be present during a meter test.

On April 7, 2020, NW Natural filed a petition for a temporary waiver of OAR 860-021-0130(2) that was granted on May 5, 2020. On July 6, 2020, the Commission extended the waiver until January 6, 2021, and on December 30, 2020, the Commission extended the waiver until October 6, 2021. NW Natural is now seeking a further extension of 6 months, through April 6, 2022, due to the potential exposure to the COVID-19 virus for both customers and NW Natural employees.

MOTION TO AMEND ORDER NO. 20-501

1	Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), files
2	this motion under the provisions of ORS 756.568 and in accordance with OAR 860-021-
3	0005. Due to the continuing COVID-19 public health emergency, NW Natural requests the
4	Public Utility Commission of Oregon (Commission) amend Order No. 20-501 and extend the
5	temporary waiver of OAR 860-021-0130(2), which currently expired October 6, 2021, for an
6	additional 6 months, until April 6, 2022.
7	OAR 860-021-0130(2) relates to meter tests, specifying that "a customer and/or a
8	designated representative shall have the right to be present at any meter test." Good cause
9	exists to seek an extended waiver of this rule because of COVID-19. Due to the fluidity of
10	the public health emergency, the Company has been monitoring the situation and has
11	continually evaluated the need to seek a continuance of this waiver.
12	I. BACKGROUND
13	On March 8, 2020, Oregon Governor Kate Brown declared a state of emergency due
14	to the public health threat posed by COVID-19. On March 23, 2020, the governor issued
15	Executive Order No. 20-12 to Stay Home, Save Lives, ordering Oregonians to stay at home,
16	and among other things, requiring social distancing measures. On April 7, 2020, NW Natural

1	requested and was granted a waiver of OAR 860-021-0130(2), effective May 6, 2020. On
2	July 6, 2020, the Commission extended the waiver until January 6, 2021, and on December
3	30, 2020, the Commission extended the waiver until October 6, 2021. The continuing health
4	emergency supports our request for a continuance of the waiver of OAR 860-021-0130(2).
5	The extension of the waiver will benefit customers and NW Natural employees by limiting
6	potential exposure to COVID-19 through social distancing.
7	II. GOVERNING AUTHORITY
8	As mentioned above, OAR 860-021-0130(2) specifies "a customer and/or a
9	designated representative shall have the right to be present at any meter test." OAR 860-021-
10	0005 allows the Commission to grant waivers of any of the Division 021 rules for good cause
11	shown.

14	IV. REQUEST FOR WAIVER EXTENSION
15	NW Natural seeks a 6-month extension of the waiver of OAR 860-021-0130(2)
16	granted by the Commission in Order No. 20-501. Good cause exists to grant NW Natural's

1	request for waiver. Extending the waiver benefits customers and NW Natural employees by
2	limiting potential exposure to COVID-19 through social distancing. The Company will
3	continue to pull and test meters as needed, and will send to the customer the results of any
4	meter tests, including those that the customer would have otherwise been permitted to
5	witness. Since NW Natural's current waiver of OAR 860-001-0420(2) expired on October 6,
6	2021, the Company respectfully requests that the Commission promptly consider this motion
7	in order to ensure that the waiver continues, and that the interruption is as limited as
8	practicable.
