For the reasons set out below, Portland General Electric Company ("PGE") hereby requests that the remaining procedural schedule in this docket be suspended.

PGE initiated this docket December 31, 2013, with the filing of its Renewable Portfolio Standard Implementation Plan ("RPIP") and its filing included the information required by OAR 860-083-0400. PGE updated the RPIP on February 18, 2014. The Citizens' Utility Board ("CUB"), Renewable Northwest ("RNW"), the Industrial Customers of Northwest Utilities ("ICNU"), and the Oregon Department of Energy ("ODOE") intervened in the docket. No other party sought intervention.

Settlement discussions between PGE, Staff of the Public Utility Commission ("Staff"), CUB, ICNU, ODOE, and RNW (collectively the "Parties") were held on February 6, 2014. As a result of those and subsequent discussions, an agreement in principle resolving all issues in this docket was reached among the Parties. The Parties are in the process of reviewing a draft stipulation and request more time to complete that process.

PGE respectfully requests that the remaining procedural schedule in this docket be suspended. The other Parties support this motion.

CONCLUSION AND EXPEDITED CONSIDERATION REQUEST

For the reasons discussed above, PGE requests that the administrative law judge issue an order suspending the remaining procedural schedule in this docket. Pursuant to the schedule set in this docket, Staff and intervenor comments are due today. Accordingly, expedited consideration of this motion is requested.
