Investigation into the Oregon Telephone Assistance Program and Lifeline Marketing Practices STAFF'S SECOND MOTION TO MODIFY PROCEDURAL SCHEDULE

Staff of the Public Utility Commission of Oregon ("Staff") requests that the administrative law judge modify the procedural schedule in this docket. Under the schedule adopted in this case, Staff was to conduct two workshops with interested persons. The first was conducted on March 26, 2014 and the second workshop was re-scheduled and conducted on June 10, 2014. The current schedule directs Staff to file a status report and recommendations with the Commission within ten business days following the second workshop. Interested parties may then file comments on Staff's filing within five business days.

At the second workshop on June 10, 2014, Staff and the interested persons attending the workshop agreed to conduct a third workshop/settlement conference on July 22, 2014. Staff and the interested persons agreed that it will be beneficial to allow for discussion of specific written proposals before Staff files its recommendations in this docket.

Therefore, Staff moves to modify the schedule in this docket to reflect that Staff will file a status report and recommendations within ten business days of the *third* workshop that will be conducted on July 22, 2014. Interested parties will still have the opportunity to file comments on Staff's filing within five business days.

On June 12, 2014, counsel for Staff sent an e-mail to the service list of this docket and that of Docket No. AR 574 confirming Staff's intent to file this motion. Counsel for Staff did

not receive any objections.

Staff respectfully requests that the procedural schedule be modified to reflect that Staff will file a status report and recommendations within ten business days of the third workshop that will be conducted on July 22, 2014. Interested parties will have the opportunity to file comments on Staff's filing within five business days.
