***EXPEDITED CONSIDERATION  
REQUESTED***

1           PacifiCorp d/b/a/ Pacific Power, respectfully moves the Public Utility Commission  
2 of Oregon (Commission) to extend the deadline for the submission of PacifiCorp's reply  
3 testimony and Commission Staff's and the intervenors' cross-answering testimony from  
4 July 14, 2014, to July 23, 2014. The testimony submitted to date in this docket presents  
5 issues that overlap with PacifiCorp's 2015 Transition Adjustment Mechanism (TAM), docket  
6 UE 287. The proposed change to the procedural schedule aligns the due dates of reply and  
7 cross-answering testimonies in both dockets.

8           PacifiCorp contacted the parties on the service this in this docket, and no party  
9 opposes this motion. At this time, no changes to the remainder of the procedural schedule  
10 are proposed, but the parties plan to discuss whether any additional changes to the schedule  
11 are necessary during a settlement conference on July 9, 2014.
