EXPEDITED CONSIDERATION REQUESTED

PacifiCorp d/b/a/ Pacific Power, respectfully moves the Public Utility Commission 1 2 of Oregon (Commission) to extend the deadline for the submission of PacifiCorp's reply 3 testimony and Commission Staff's and the intervenors' cross-answering testimony from 4 July 14, 2014, to July 23, 2014. The testimony submitted to date in this docket presents issues that overlap with PacifiCorp's 2015 Transition Adjustment Mechanism (TAM), docket 5 6 UE 287. The proposed change to the procedural schedule aligns the due dates of reply and 7 cross-answering testimonies in both dockets. 8 PacifiCorp contacted the parties on the service this in this docket, and no party 9 opposes this motion.
