STAFF'S MOTION REQUESTING WAIVER
OF OAR 860-083-0350(4)


Pursuant to OAR 860-083-0005(2), Staff of the Public Utility Commission of Oregon (Staff) requests a waiver for OAR 860-083-0350(4), which requires written comments on an electric company's or an electricity service supplier's report to be filed within 45 calendar days of the date of the filing of the report. Without the waiver request being granted, Staff's and any intervenor party's written comments would be due on or about July 15, 2014. Staff requests a waiver such that its and other any party's written comments would not be due until August 15, 2014. Further, Staff requests that the remainder of the schedule be similarly extended by the same 30-day period (i.e. the electric company or ESS has 30 calendar days to respond to any written comments that are filed, so this due date would be extended to September 15, 2014).

Staff makes this request due to current workload requirements placed upon Adam Bless, the Staff lead analyst assigned to this matter, as well as Mr. Bless' previously-scheduled vacation. Staff has not discussed this motion with any party or the filing-company.


