Addendum to Certificate of Compliance for Admission *Pro Hac Vice*

Gloria D. Smith is a full time employee of the Sierra Club, which is a non-profit corporation and the entity Ms. Smith is seeking to represent *pro hac vice* in Oregon Public Utilities Commission Docket No. UM 1707. Ms. Smith therefore does not include a certificate of professional liability insurance with this application because she will not be engaged in the private practice of law. UTCR 3.170(1)(e) ("If the attorney will engage in the private practice of law in this state provide a certificate of insurance covering the attorney's activities in this state and providing professional liability insurance substantially equivalent to the Oregon State Bar Professional Liability Fund plan."); ORS 9.08(2)(b) ("For purposes of paragraph (a) [establishing authority to require professional liability insurance], an attorney is not engaged in the private practice of law if the attorney is a full-time employee of a corporation...").
