

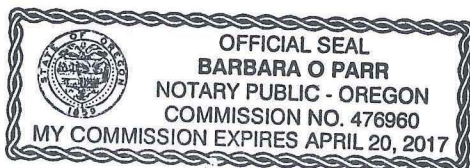
1. My name is Joe Barra. I am a senior consultant in Customer Strategy & Business Development at Portland General Electric Company ("PGE").
