Joint Motion to Modify Procedural Schedule and Request for Expedited Consideration

Cypress Creek Renewables, LLC ("Cypress Creek") and PacifiCorp d/b/a Pacific Power ("PacifiCorp") respectfully request that the Public Utility Commission of Oregon (the "Commission") issue an order modifying the procedural schedule in this docket. On November 7, 2016, the parties to this docket agreed to a procedural schedule, which was memorialized in the Prehearing Conference Memorandum issued by Administrative Law Judge Allan J. Arlow on November 8, 2016. Since the prehearing conference in this matter, Cypress Creek and PacifiCorp have had initial discussions about a settlement that would resolve the issues between them in this docket. In order to allow them to continue these discussions, Cypress Creek and PacifiCorp have agreed to request a two week delay in the procedural schedule, as set forth below. Renewable Northwest, the Northwest Independent Power Producers Coalition, and the Renewable Energy Coalition have agreed to the requested delay, and both Portland General Electric Company and Staff do not oppose it.

As the original procedural schedule's due date for Cypress Creek to submit its Motion for Summary Judgment is today, Cypress Creek and PacifiCorp respectfully request expedited consideration of this motion pursuant to OAR 860-001-0420(6).
