15	comments on an electric company's or electricity service supplier's (ESS) RPS compliance		
16	report within forty-five calendar days of the filing. The electric company or ESS is then		
17	permitted to file a written response to comments within thirty days thereafter. Comments were		
18	to be filed by July 15, 2017, and PGE's response comments would have been due by August 15,		
19	2017. However, due to unforeseen circumstances, Staff was not able to meet the deadline for		
20	initial comments. Oregon Department of Energy (ODOE) and Industrial Customers of		
21	Northwest Utilities (ICNU) are intervenor in this case, and have also not filed comments to date.
