Expedited consideration requested

Portland General Electric Company ("PGE") and SSD Clackamas 1, LLC ("Complainant") jointly request that Administrative Law Judge ("ALJ") Allan Arlow grant a two-week extension of the deadline to respond to Complainant's motion for partial summary judgment from the current deadline of April 30, 2018, to a new deadline of May 14, 2018.
