10	Pursuant to OAR 860-001-0420(2) and OAR 860-001-0420(6), Staff of the Public Utility		
11	Commission of Oregon (Staff) moves the Administrative Law Judge (ALJ) for an expedited		
12	ruling suspending the schedule for testimony in this docket. On December 22, 2022, ALJ Spruce		
13	issued a pre-hearing conference memorandum, setting a schedule for this docket. The current		
14	schedule has testimony beginning on March 10, 2023.		
15	On February 15, 2023, Parties conducted a settlement conference where it was		
16	determined that additional time is needed to permit meaningful settlement discussions. All		
17	Parties agreed to rescheduling the second settlement conference, changing the date from		
18	February 28 th to March 14 th . Since the first round of testimony is due before the second		
19	settlement conference will occur, all Parties have agreed to a temporary suspension of the		
20	schedule for testimony until March 31, 2023, with a new schedule to be agreed upon, if needed,		
21	during the March 14 th settlement conference.		
22	All parties to this proceeding, including Staff, Lumen, Oregon Citizens' Utility Board		
23	(CUB), and Intervenors have agreed to support a temporary suspension of the testimony schedul		
24	to facilitate settlement. Staff requests expedited consideration of this motion as the schedule in		
25	this proceeding has Staff testimony on March 10, 2023. Counsel for Staff has conferred with		
26	counsel for each party regarding this motion, and no party objects.
