Deferred Accounting of Earnings Related to US Tax Cuts and Jobs Act.

MOTION FOR PROTECTIVE ORDER

EXPEDITED CONSIDERATION REQUESTED

Pursuant to ORCP 36(C)(7) and OAR 860-001-0080, Idaho Power Company ("Idaho Power" or "Company") moves for the entry of the Public Utility Commission of Oregon's ("Commission") general protective order in this proceeding. Good cause exists to issue a Protective Order to protect commercially sensitive and confidential business information related to the Company's filed Application for Deferred Accounting. Because Idaho Power will be responding to Staff's Data Requests tomorrow, Idaho Power requests that the general protective order be entered on an expedited basis.

In support of this Motion, the Company states:

- 1. The Commission's rules authorize Idaho Power to seek reasonable restrictions on discovery of trade secrets and other confidential business information. See 860-001-0080; ORCP 36(C)(7) (providing protection against unrestricted discovery of "trade secrets or other confidential research, development, or commercial information"); see also In re Investigation into the Cost of Providing Telecommunication Service, Docket UM 351, Order No. 91-500 (1991) (recognizing that protective orders are a reasonable means to protect "the rights of a party to trade secrets and other confidential commercial information" and "to facilitate the communication of information between litigants").
- 2. On December 29, 2017, Idaho Power filed its Application for Deferred Accounting Related to the US Tax Cuts and Jobs Act. Discovery is ongoing. Certain documents responsive

to data requests may contain confidential material, including but not limited to proprietary cost

data and models, commercially sensitive load and resource projections, confidential market

analyses and business projections, and confidential information regarding contracts for the

purchase or sale of electric power, power services, or fuel. Public disclosure of the confidential

information would be detrimental to Idaho Power and its customers.

For the foregoing reasons, Idaho Power requests entry of a standard Protective Order
