9 Pursuant to OAR 860-001-0080(1), Crooked River Ranch Water Company (“Company”)
10 moves for entry of the Commission’s standard protective order in this proceeding. Good cause
11 exists to issue a Protective Order to protect commercially sensitive or confidential business
12 information related to the Company’s operations, its system, and its member customers. In
13 support of this Motion, the Company states:

15 OAR 860-001-0080(3)(a) authorizes the Company to seek reasonable restrictions on
16 discovery of sensitive commercial information and other confidential business information.

18 The Company anticipates that Commission Staff, and perhaps other parties to this docket,
19 will request sensitive or confidential information, including information that would identify
20 customer-specific data. The Company has a legitimate business reason to keep such information
21 confidential.

23 It is substantially likely that Staff and other parties in this proceeding will seek to
24 discover information held by the Company, including the sensitive or confidential business
25 information described above. Issuance of a protective order will facilitate the production of
26 relevant information among the parties.
